Kerry first explained how the project selection process occurs with Action Plan teams. He then explained that all NEPs received an increase for their FY2009 budget.

The workplan describes a budget request to EPA for executing 23 contractual projects and several administrative type budgets.

The Chairman asked if there was any objection to the Workplan. Doug Jacobson abstained from voting. There was no objection; therefore, the workplan was approved.

V. Discussion Items

A. Importance of Spill Prevention and Louisiana One Call-Ed Landgraff, Shell Pipeline (20 minutes) Ed stated that he had a resolution that he would like the MC to review while he went through his presentation.

He stated that he was proud that Shell Pipeline has a bio-diversity action plan. He also stated that Shell has systems that run through the Delta National Wildlife Refuge and produced a CD of the wildlife refuge.

He stated that the objective today is to prevent oil spills and he will go over a few scenarios on how that can take place.

He first gave an overview of how the oil and gas industry operates.

Ed showed maps of eroding coastal Louisiana. As marsh edge erodes away, pipelines have less cover in them and become more susceptible to damage. This erosion promotes boat traffic in that area, also not having that protection blanket from storms and hurricanes, those pipelines could flex or prematurely corrode and cause oil spills. These are reasons why Shell Pipeline is involved in coastal restoration and with BTNEP.

He then showed examples of third party damage. Third party damage is a source of the oil industries largest spills. And it is these kinds of spills that Shell is trying to prevent.

The event that brought Ed to the meeting today happened 5 miles north going towards LOOP from Port Fourchon. He stated they air patrol their pipelines, and the air patrol called in saying there was a barge working on top of their pipeline. Shell sent people out and found a work barge doing plug & abandon work on a well. The workers said that being out in open water, he did not need a coastal use permit. A Shell pipeline ran right between the two spuds that were dropped from this barge. This could have been a very big spill.

With a coastal zone use permit, this near mishap could have been prevented.

So, Ed is promoting the coastal zone use permit and/or the 811 One Call Ticket, which must be obtained before breaking ground, digging or excavating.

Ed stated that the resolution he put before the MC asks nothing more than to follow the law and to bring the awareness level up of the people who operate and industries that operate in the coastal zone.

Vince Guillory stated that this probably couldn't be resolved at this meeting. Everyone probably needs time to think this over. He asked if it could be brought up again at the next meeting. Kerry said that it could.

Vince motioned to defer this topic with possibly further comments from DNR, David Muth seconded the motion. There were no objections.

B. Barataria-Terrebonne Rapid Assessment Project-Marilyn Barrett O'Leary

Michael Massimi introduced Dr. O'Leary who is the contractor for this project. She stated that this project reflects something that BTNEP is doing all the time, and that is combining science with outreach and trying to get the whole system to work; trying to take care of the health of the habitat in relation to

the people that are also part of the system.

She stated that the State of Louisiana spent 5 years developing the Invasive Species Management Plan with the idea of being able to figure out how to control and prevent invasives species that affect the people and the wildlife.

She stated that this project is part of that plan. The goal of the project is to rapidly assess the waters of the BTNEP area. In order to get a baseline of the invasive species that are present in this area, a group of volunteers, scientists from Louisiana, Mississippi and Texas, will spend a week gathering samples from specific places.

This project will also educate the people at Wildlife & Fisheries and the Dept. of Natural Resources that work out in the field and connect them with university people. Most of these people study the native plants and animals, not the invasives.

She states that invasives are a sign of a weakened or changed eco-system. They take advantage of weakness; they are capable of taking over.

She then went over the structure and schedule of the project.

Kerry asked who has volunteered. Michael stated that he has volunteers from NSU, LDWF, LUMCON, and LDNR.

He stated that the data collected would be available in a final report, which will serve as a baseline for future monitoring. He stated also that this will be put on the BTNEP website.

C. Update on Apple Snail and invasive Carp in Davis Pond-Brac Salyers, Aquatic Nuisance Species Coordinator, LDWF (10 minutes)

Michael then introduced Brac Salyers. Brac showed the MC slides of freshwater invasive species such as the apple snail. He gave facts about the snail. He stated that the only way to eradicate these snails is to put a highly toxic poison into the water, but this will kill every other animal that is in that water body. The snails also eat a wide variety of plants.

He stated the biggest concern is when these snails go unchecked and they reproduce over and over again.

Michael showed a map of reported sites of the apple snail.

Brac then discussed the Grass Carp, Common Carp and the Silver Carp. Again, their biggest threat is their massive ability to reproduce and the large size they can become. He stated they are a bigger problem in the northern part of the Mississippi River watershed but are also a big problem in our area.

He stated that a possible new invasive coming to Louisiana is a snake head. There was a population identified in Arkansas in March started by a fish farmer. When this fish farmer found out there was legislation stating having snakeheads was illegal, he dumped all his fish on the other side of the levee.

VI. New Business

Linda Pace announced that a public notice was sent out yesterday that CELP, that is funded by NOAA, has submitted a draft plan for states that have Coastal Zone Management plans to compete for funds.

Kerry announced that BTNEP went through its EPA evaluation and passed with exemplary remarks. There is a
