IV. Action Item

FY 2011 Workplan (1 hr.)

This draft workplan for fiscal year 2011(October 1, 2010- September 30, 2011), will be submitted to EPA in June. The workplan describes a budget request to EPA for executing 24 contractual projects and several administrative type budgets.

Kerry informed the MC that for FY2011, BTNEP will receive \$800,000. With state budget cuts, he stated that the program will have to use a portion of these funds to supplement its state budget. The program will have a hard time matching these federal funds, but will use non-federal funds put towards partnership projects to make the match.

After Kerry gave a brief description of each project, Gary LaFleur asked if the fence at the Grand Isle State park was to keep people out of the area. Dean Blanchard said mostly predators such as coyotes, but the signage would be used to keep the public out also.

Susan Testroet-Bergoron made a motion to accept the workplan, Archie Chaisson seconded the motion. There were no questions or comments. There was no further discussion. A vote was taken and approved with one abstention by Doug Jacobson.

V. Discussion Items

A. BP Oil Spill Impacts

1. Impacts on Oysters-Dr. Earl Melancon, NSU

Earl informed the MC that he currently has a 8-year CWPPRA project in Terrebonne Bay. He stated one site of the project has been impacted by the oil. He has seen oil along the shoreline. He stated no oyster samples have been taken yet. He is finding that the oil is up in the grass but none has been found in any of his structures below water. He has seen on his structures encrusting barnacles and other associated type organisms that don't appear to be impacted at this time. He is also seeing small fish laying their eggs in the oyster shells.

He stated that he is optimistic that what he is seeing may not be as catastrophic as he thought it might be. He said the state is putting massive volumes of freshwater into the system through every diversion possible. He stated that water temperatures are already at 90 degrees. When you have significant freshwater and low salinity, you will have a significant impact on the oyster populations. With the oil coming in from the Gulf, that oil is impacting on inter-tidal shallow water oysters. And those are the most vulnerable and will be the most significantly impacted IF oil hits them.

If there is a failed spat set this season, there will be no way to really tell if it is due to the oil spill. Earl stated he's never seen a failed spat set in Terrebonne Bay before. He stated he will know in about 3 weeks if the spat set has failed.

Earl stated he attended the Louisiana Seafood Promotion and Marketing Board meeting two weeks ago. He stated that people with the Board stood up and stated that consumer confidence has been totally eroded in this country for Louisiana seafood. Restaurants in the country are putting up signs that they are not serving Louisiana seafood.

John Tesvich asked Earl if the opening of the Davis Pond Diversion made a difference in the oil impact in the estuary. Earl stated in the long haul, no. He stated what he has experienced with Davis Pond is that this time of year with southeasterly winds, which prevails, is a tendency to push water into the system; oil is going to come up with it. When those winds subside, that dark decaying water will hit the system. Oysters will clam up and survive for a day or two. But other animals and fish will not.

2. Fisheries Impacts-Vince Guillory, LA Dept. of Wildlife & Fisheries

Vince stated he is much more concerned about the impacts on our fisheries than on our natural resources. He stated our natural resources can recover, however, our fisheries may not. We won't know what the overall impacts are on our economics and fisheries until after all the oil is gone. Vince handed out two maps of all the fishery closures. The maps show there has been a dramatic impact already.

LDWF funded an economic study of fisheries and wildlife in Louisiana using 2003 data. Shrimp, oyster and blue crab are Louisiana's dominant in-shore commercial fisheries in the BTNE. On a

state-wide basis, these three fisheries support over 20,000 jobs, generate annual earnings of \$287 million and have a total economic effect of \$1.8 billion. The recreation fisheries, on a state-wide basis, support 83,000 jobs and generate annual earnings of \$190 million and have a total economic effect of \$793 million. The study did not, however, breakdown the data by basin. But the BT estuary comprises a significant portion of our fisheries.

The BT estuary produces 71% of the brown shrimp landings, 75% of the oyster landings, approximately 2/3 of the blue crab landings, 10% of oyster landings from public oyster grounds.

Vince stated there have been a number of impacts on the fishing industry. There have been closures, loss of critical fisheries infrastructure (docks and plants) and the continued decline in numbers of commercial fishermen.

3. Natural Resources Damage Assessment-Darin Lee, LA Dept. of Natural Resources Darin stated that NOAA has taken the lead in the NRDA process and plans are being developed and some are already in place. Monitoring was taking place before the oil spill took place and now monitoring is taking place in the affected areas. The monitoring ranges from deepwater coral impacts to SAVs to marshes to fish and water quality. He stated there are NRDA teams out everywhere. However, the impacts really have not been looked at yet. Only the location of where oil has been found and the severity of it have been documented.

Earl suggested that the MC call upon CPRA to update the public on what agencies are doing what throughout this whole process.

Kerry stated he has had conference calls with the ANEP and the ANEP Board has taken Kerry's recommendation that each NEP write a letter to EPA requesting that the NEPs impacted by this oil spill is a part of this NRDA process. He stated that these NEPs expect to be a part of this process and to determine what kind of damages has to be paid by the responsible party.

4. Update on US Coast Guard Activities-Mark McManus, US Coast Guard Mark informed the MC that the Coast Guard was responsible for setting up the Incident Command Centers for the oil spill. The Morgan City Unit is dealing with parish EOC's. Mark stated that the two he has the most focus on are Lafourche and Terrebonne. He stated that they are making sure that the local concerns are being addressed in a quick and rapid fashion.

He stated that some of the issues the Coast Guard is dealing with are housing for workers and making sure navigational canals are safe.

Gary LaFleur asked if there were cleaning stations for boats. Mark said there were 17 decontamination sites; one in Cocodrie, two in Fourchon, a few along Southwest Pass and the entrance of the Mississippi River and further east along the coast of Mississippi.

- 5. **Update on Bird Surveys-**Dean Blanchard, BTNEP In Richard DeMay's absence, Dean gave a brief update on bird surveys.
- 6. Spill Associated Volunteer Efforts-Mel Landry, BTNEP Mel gave a presentation on volunteer efforts since the oil spill and supply donations given for the oil spill clean up.
- Spill Associated Media-Shelley Sparks, BTNEP
 The MC was presented with a power point presentation in Shelley's absence on media

interviews since the oil spill.

8. Spill Associated Environmental Impacts-Kerry St. Pe', BTNEP

Kerry reminded the MC that he worked 25 years for the Water Pollution Control Division under LA Dept. of Wildlife & Fisheries and eventually that division was moved to the Dept. of Environmental Quality. One of his duties during that time was to respond to oil spills. He served as state on-scene coordinator for this region and covered 100's of oil spills per year. There was usually no media coverage for these spills. The largest spill, Kerry stated, he covered in those 25 years, was a 10,000 barrel spill in Lake Barre'. This current spill surpassed that spill in two days. The ecological damage of that spill to the Terrebonne estuary was far greater than this current spill, but there is far more oil in the Gulf. But the impacts from the Deepwater Horizon Spill to our fisheries and culture now are far greater. Kerry stated BP will never be able to compensate for all the losses.

Kerry then explained the toxicity, solubility and chemical makeup of oil, and its effects on the environment.

Kerry then discussed dispersants and their use and impacts. He also discussed the effects of oil on various plants.

Kerry said the BTNEP could not support sand berms. Kerry has been asked for his opinion of them from several people and he has freely given it. He stated the sand berms were originally going to be a continuous sand levee with a 21 to 1 slope, 20 ft. across, 6 ft. high. Kerry's concern is how long will the sand berm last. Another concern is not only are you affecting the ingress and egress of the fishery organisms, but you are changing the whole hydrology, changing the time it takes water to leave the estuarine system, you are restricting the flow of water out of the estuary and where is the sand going to come from. He stated he is concerned that the sand will no longer be available for legitimate coastal restoration of the barrier islands.

Kerry then gave his opinion on using rock dikes as a oil protection technique. Rocks will keep sand from moving from one place to another.

Kerry then voiced his opinion on the Incident Command System. He feels there is not enough information getting out to the public from the state and federal government.

He stated that his role has been to spread facts on the impacts of the spill. The BTNEP's media and volunteer program have played an important role in this effort.
